Summer School and Research Symposium:

Analyzing Regional Social Cohesion: Theoretical and Methodological Training for Advanced Research 2-7 July 2012, University of Luxembourg

Social Cohesion is a concept/paradigm which is utilized by scholars and leaders throughout the world. Despite its widespread acceptance, however, little conceptual clarity has been achieved. Different approaches/definitions of social cohesion exist in different world regions yet all regions are confronted with the same challenge: creating social cohesion across borders. For example, the African Union refers to social cohesion in terms of anti-colonialism, African cultural heritage and continental cooperation. The Andean Community and Mercosur discuss the term with reference to social exclusion/integration and poverty reduction. In Europe definitions vary within the continent as the European Union approaches cohesion as bridging development gaps between regions whereas the Council of Europe focuses on embracing cultural diversity within continental notions of citizenship and the extension of social and cultural rights. Finally, in North America, one finds little regional reference to social cohesion due to the structure and content of the North American Free Trade Agreement.

The RISC/CRIS summer school provides training for Ph.D. candidates, postdoctoral researchers and research-oriented practitioners, on theoretical and methodological aspects of research related to social cohesion. Moreover, because cohesion is an emerging topic in regional integration debates, the summer school explicitly frames discussions in regional terms. Potential participants should work on cohesion-related issues such as: migration, social policy, social integration, security, environmental management, ethnic conflict, development, social risk/vulnerability, the quality of democracy and citizen participants should have acquired:

- 1) an overview of present debates surrounding social cohesion strategies in different world regions;
- 2) methodological skills aimed at cross-regional, comparative analyses of social cohesion issues;
- 3) insight into present and potential future relationships between social cohesion and regional integration;
- 4) comprehension of the practical implications of social cohesion discussions through interaction with governmental officials and representatives of nongovernmental organizations







The school will be organized around keynote lectures given by leading scholars from different world regions in the mornings. In the afternoons, students will present their own research during conference sessions. The school includes a field trip to a European institution and break-out sessions with practitioners working in international development.
